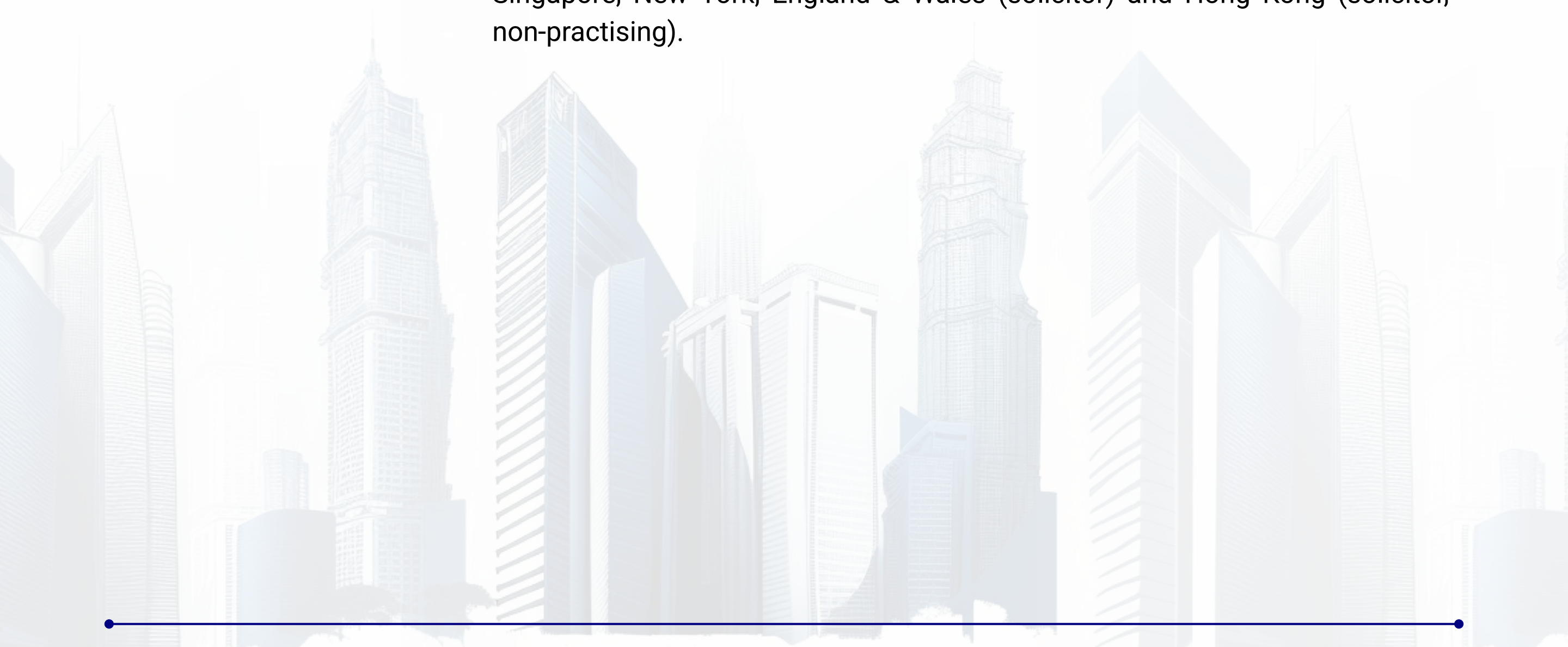

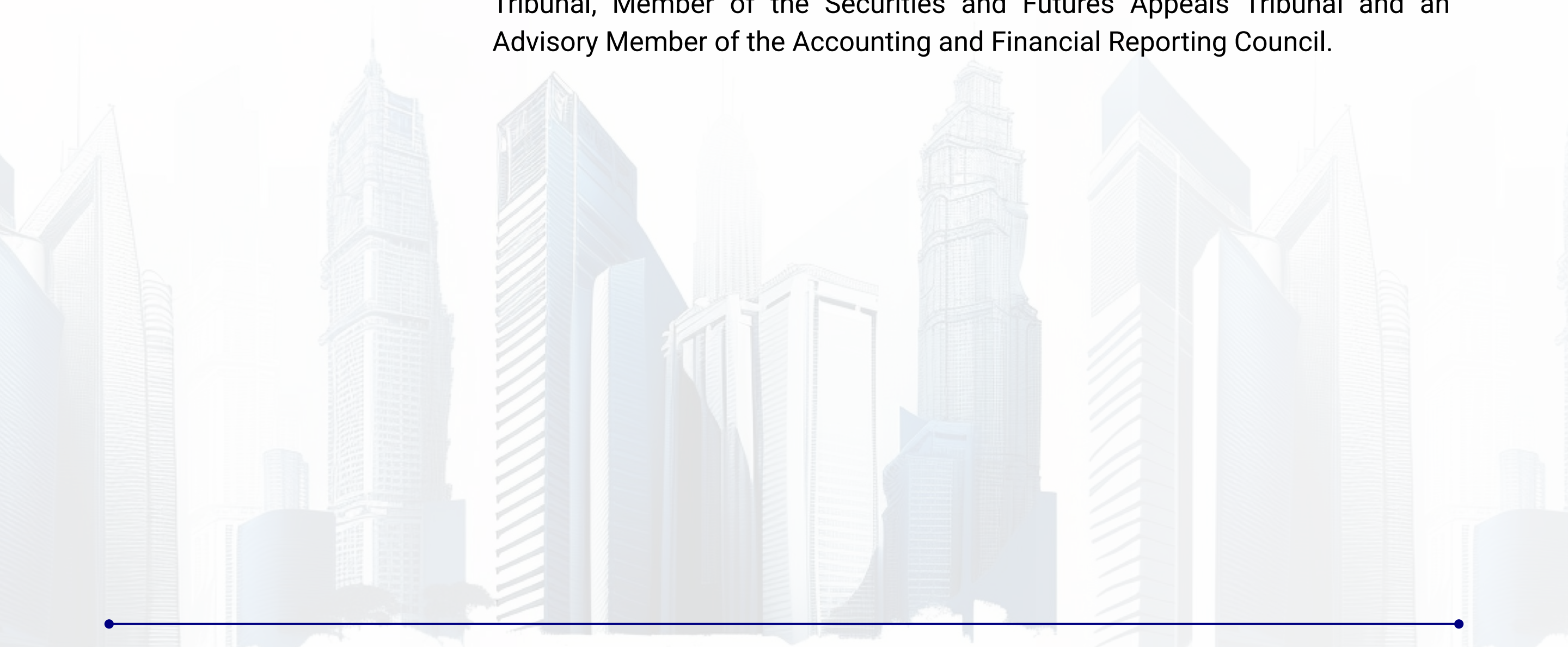


### **Dr. CHRISTOPHER TO**
